DECLARATIONS

I/We hereby declare that I am /we are non-resident Indian(s) of Indian origin, I/We understand that the above account(s) will be opened on the basis of the statements/declarations made by me/us and I/we also agree that if any of the statements/declarations made herein is found to be not correct in material particulars, you are not bound to pay any interest on the deposit made by me/us.

In the matter of cheques lodged by me/us with you from time to time for collection or negotiation, where the cheques are payable at places where you have not established your branches, I/we request you to collect them through any bank, entirely at my/our risk and responsibility. Where such drafts/cheques are negotiated by you and the same are lost in transit or otherwise, I/we hereby agree to reimburse to you the full amount of such drafts, cheques on demand.

I/We request and authorise you to honour all cheques or other orders drawn by me/us on the said account and I/We request you to debit such cheques to the said account, whether such account be for the time being in credit/overdrawn. Where such instructions/cheques require remittance of funds outside India, the remittance may be made only in accordance with the then prevailing Exchange Control Regulations, covering the scheme under which the deposit was accepted, and also covering the remittance desired.

I/We agree to comply with and to be bound by the bank's rules for the time being in force for the conduct of such account/s. I/We declare that the rules in force have been read by me/us.

I/We agree that no claim will be made by me/us for any interest on the deposit/s for any period after the date/s of maturity of the deposit/s. I/We agree to abide by the provisions of the foreign Currency (Non-Resident) Account/Non-Resident (External) Account/Non-Resident (Ordinary) Account Scheme. I/We hereby undertake to intimate to you about my/our return to India for permanent residence immediately on arrival.

I/We authorise the bank to automatically renew the deposit on the due date for an identical period unless the instructions to the contrary from me/us are received by the bank before maturity. I/We understand that the renewal will be in accordance with the provisions of the Reserve Bank of India's scheme in force at the time of renewal.

I/We further understand that the interest applicable on such renewals will be at the applicable ruling rates on the date of maturity and that the renewal will be noted on the deposit receipt on my/our presenting the same on the maturity date or later for renewal/ payment.

I/We agree that if premature withdrawal is permitted at my/our request, the payment of interest on the deposit may be allowed in accordance with the prevailing stipulations laid down by Reserve Bank of India in this regard.

I/We hereby undertake that I/We will not make available to any person in India any foreign currency against reimbursement in India in rupees or in any other manner.
